### **HOUSEHOLD SELECTION PROTOCOL:**

- Three attempts should be made at different times when you are in the PSU (or on different days) to recruit an eligible respondent from the randomly selected household. Ideally at least one attempt should be made on the weekend, if you are in the area over the weekend.
- If after three attempts it is still not possible to recruit an eligible candidate from the randomly selected household, the household will need to be replaced by counting three households past the *last main household* along the walking path. In each replacement household, the interviewer will make up to three attempts to secure an interview. If the attempts to recruit an eligible respondent at the replacement household are unsuccessful, the interviewer will continue to use the right-hand rule and the interval of three households to select the next replacement household. This process will be repeated until the required number of completed interviews is obtained in the selected PSU.

**\*NOTE:** Definition of household:

- Household is a dwelling in which members live permanently in that dwelling and have a cooking facility (such as a stove, a fire in the courtyard, etc. – any basic cooking facility is valid).
- In the case of communal living where multiple families live in an apartment, a household is defined by a shared cooking pot. That is, members who share food cooked from a common pot or shared from the same budget are considered a household.
- In Afghanistan, a small portion of the population lives in compounds. For our surveys: those who live in compounds and use separate cooking facilities and separate budgets are considered as several households not a single household. But those who live in compounds and use the same cooking facility and same budget are considered a single household.
- All interviews will be attempted at a person’s home, which can be anything from a hut to a single house
